GLOSSARY

The following definitions shall apply to and are used in this Request for Qualifications:

“Joint Meeting” - refers to the North Arlington – Lyndhurst Joint Sewer Meeting.

“Qualification Statement” - refers to the complete responses to this RFQ submitted by the Respondents.

“Qualified Respondent” - refers to those Respondents who (in the sole judgment of the Joint Meeting) have satisfied the qualification criteria set forth in this RFQ.

“RFQ” - refers to this Request for Qualifications, including any amendments thereof or supplements thereto.

“Respondent” or “Respondents” - refers to the interested firm(s) that submit a Qualification Statement.

SECTION 1

INTRODUCTION AND GENERAL INFORMATION

1.1. Introduction and Purpose.

The Joint Meeting is soliciting Qualification Statements from interested persons and/or firms for the provision of engineering services, as more particularly described herein. Through the Request for Qualification process described herein, persons and/or firms interested in assisting the Joint Meeting with the provision of such services must prepare and submit a Qualification Statement in accordance with the procedure and schedule in this RFQ. The Joint Meeting will review Qualification Statements only from those interested persons and/or firms that submit a Qualification Statement that includes all the information required to be included as described herein (in the sole judgment of the Joint Meeting). The Joint Meeting intends to qualify person(s) and/or firm(s) that (a) possesses the professional, financial and administrative capabilities to provide the proposed services, and (b) will agree to work under the compensation terms and conditions determined by the Joint Meeting to provide the greatest benefit to the taxpayers of North Arlington and Lyndhurst.

1.2. Procurement Process and Schedule.

The selection of Qualified Respondents is not subject to the provisions of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. The selection is subject to the "New Jersey Local Unit Pay-to-Play" Law, N.J.S.A. 19:44-20.4 et seq., however. The Joint Meeting has structured a procurement process that seeks to obtain the desired results described above, while establishing a competitive process to assure that each person and/or firm is provided an equal opportunity to submit a Qualification Statement in response to the RFQ. Qualification Statements will be evaluated in accordance with the criteria set forth in Section 2 of this RFQ, which will be applied in the same manner to each Qualification Statement received.

Qualification Statements will be reviewed and evaluated by the Joint Meeting and its legal and/or financial advisors (collectively, the "Review Team"). The Qualification Statements will be reviewed to determine if the Respondent has met the minimum professional, administrative and financial areas described in this RFQ. Under no circumstances will a member of the review team review responses to an RFQ for a job which they or their firm submitted a response. Based upon the totality of the information contained in the Qualification Statement, including information about the reputation and experience of each Respondent, the Joint Meeting will (in its sole judgment) determine which Respondents are qualified (from professional, administrative and financial standpoints). Each Respondent that meets the requirements of the RFQ (in the sole judgment of the Joint Meeting) will be designated as a Qualified Respondent and will be given the opportunity to participate in the selection process determined by the Joint Meeting.

The RFQ process commences with the issuance of this RFQ. The steps involved in the process and the anticipated completion dates are set forth in Table 1, Procurement Schedule. The Joint Meeting reserves the right to, among other things, amend, modify or alter the Procurement Schedule upon notice to all potential Respondents.

All communications concerning this RFQ or the RFQ process shall be directed to the Joint Meeting's Designated Contact Person, in writing.

Subsequent to issuance of this RFQ, the Joint Meeting (through the issuance of addenda to all firms that have received a copy of the RFQ) may modify, supplement or amend the provisions of this RFQ in order to respond to inquiries received from prospective Respondents or as otherwise deemed necessary or appropriate by (and in the sole judgment of) the Joint Meeting.

1.3. Conditions Applicable to RFQ.

Upon submission of a Qualification Statement in response to this RFQ, the Respondent acknowledges and consents to the following conditions relative to the

submission and review and consideration of its Qualification Statement:

- This document is an RFQ and does not constitute a Request for Proposals (“RFP”), nor does it commit the Borough to issue an RFP.
- All costs incurred by the Respondent in connection with responding to this RFQ shall be borne solely by the Respondent.
- The Joint Meeting reserves the right in its sole judgment to reject for any reason any and all responses and components thereof and to eliminate any and all Respondents responding to this RFQ from further consideration for this procurement.
- The Joint Meeting reserves the right in its sole judgment to reject any Respondent that submits incomplete responses to this RFQ, or a Qualification Statement that is not responsive to this RFQ.
- The Joint Meeting reserves the right, without prior notice, to supplement, amend, or otherwise modify this RFQ, or otherwise request additional information.
- All Qualification Statements shall become the property of the Joint Meeting and will not be returned.
- All Qualification Statements will be made available to the public at the appropriate time, as determined by the Joint Meeting (in the exercise of its sole discretion) in accordance with law.
- The Joint Meeting may request Respondents to send representatives to the Joint Meeting for interviews.
- Any and all Qualification Statements not received by the Joint Meeting by 12:00 p.m. on January 8, 2026 will be rejected.
- Neither the Joint Meeting, nor their respective staffs, consultants or advisors (including but not limited to the Review Team) shall be liable for any claims or damages resulting from the solicitation or preparation of the Qualification Statement, nor will there be any reimbursement to Respondents for the cost of preparing and submitting a Qualification Statement or for participating in this procurement process.

1.4. Rights of The North Arlington – Lyndhurst Joint Sewer Meeting.

The Joint Meeting reserves, holds and may exercise, at its sole discretion, the following rights and options with regard to this RFQ and the procurement process in accordance with the provisions of applicable law:

- To determine that any Qualification Statement received complies or fails to comply with the terms of this RFQ.
- To supplement, amend or otherwise modify the RFQ through issuance of addenda to all prospective Respondents who have received a copy of this RFQ.
- To waive any technical non-conformance with the terms of this RFQ.
- To change or alter the schedule for any events called for this RFQ upon the issuance of notice to all prospective Respondents who have received a copy of this RFQ.
- To conduct investigations of any or all of the Respondents, as the Borough deems necessary or convenient, to clarify the information provided as part of the Qualification Statement and to request additional information to support the information included in any Qualification Statement.
- To suspend or terminate the procurement process described in this RFQ at any time (in its sole discretion.) If terminated, the Borough may determine to commence a new procurement process or exercise any other rights provided under applicable law without any obligation to the Respondents.
- The Joint Meeting shall be under no obligation to complete all or any portion of the procurement process described in this RFQ.

1.5. Addenda or Amendments to RFQ.

During the period provided for the preparation of responses to the RFQ, the Joint Meeting may issue addenda, amendments or answers to written inquiries. Those addenda will be noticed by the Joint Meeting and will constitute a part of the RFQ,. All responses to the RFQ shall be prepared with full consideration of the addenda issued prior to the proposal submission date.

1.6. Cost of Proposal Preparation.

Each proposal and all information required to be submitted pursuant to the RFQ shall be prepared at the sole cost and expense of the respondent. There shall be no claims whatsoever against the Joint Meeting, its staff or consultants for reimbursement for the payment of costs or expenses incurred in the preparation of the Qualification Statement or other information required by the RFQ.

1.7. Proposal Format.

Responses should cover all information requested in the Questions to be answered in this RFQ.

Responses which in the judgment of the Joint Meeting fail to meet the requirements of the RFQ or which are in any way conditional, incomplete, obscure, contain additions or deletions from requested information, or contain errors may be rejected.

SECTION 2

SCOPE OF SERVICES

2.1 It is the intent of the Joint Meeting to solicit Qualification Statements from Respondents that have expertise in the provision of engineering services – North Arlington – Lyndhurst Joint Sewer Meeting Engineer. Firms and/or persons responding to this RFQ shall be able to demonstrate that they will have the continuing capabilities to perform these services. The term of office for the Joint Meeting Engineer shall be one (1) year.

The job description as North Arlington – Lyndhurst Joint Sewer Meeting Engineer shall include the following:

- a. Prepare all estimates for proposed work.
- b. Attend North Arlington – Lyndhurst Joint Sewer Meeting meetings as requested.
- c. Be on call 24 hours a day for emergencies.
- d. Attend any department meetings as required.
- e. Hold a current Professional Engineering license.
- f. On call to answer all of the Joint Meeting's questions as well as any resident complaints.
- g. Provide a one-million-dollar liability policy.
- h. Be a Certified Municipal Engineer.

All capital improvement work will be billed at hourly rates as attached hereto.

SECTION 3

SUBMISSION REQUIREMENTS

3.1 **General Requirements.**

The Qualification Statement submitted by the Respondent must meet or exceed the professional, administrative and financial qualifications set forth in this Section 3 and shall incorporate the information requested below.

In addition to the information required as described below, a Respondent may submit supplemental information that its fees may be useful in evaluating its Qualification Statement. Respondents are encouraged to be clear, factual, and concise in their presentation of information.

3.2 Administrative Information Requirements.

The Respondent shall, as part of its Qualification statement, provide the following information:

- a. A summary page containing information requested in this Qualification Statement.
- b. An executed Letter of Qualification (See Appendix A to this RFQ).
- c. Name, address and telephone number of the firm or firms submitting the Qualification statement pursuant to this RFQ, and the name of the key contact person.
- d. A description of the business organization (i.e., corporation, partnership, joint venture, etc.) of each firm, its ownership and its organizational structure.
 1. Provide the names and business addresses of all Principals of the firm or firms submitting the Qualification Statement. For purposes of this RFQ, "Principals" means persons possessing an ownership, interest in the Respondent. IF the Respondent is a corporation, "Principals" shall include each investor who would have any amount of operational control over the Respondent and every stockholder having an ownership interest of 10% or more in the firm.
 2. If a firm is a partially owned or a fully-owned subsidiary of another firm, identify the parent company and described the nature and extent of the parents' approval rights over the activities of the firm submitting a Qualification Statement. Describe the approval process.
 3. If the Respondent is a partnership or a joint venture or similar organization, provide comparable information as required in (b) above for each member of the partnership, joint venture or similar organization.

- e. An executed Letter of Intent (See Appendix B).
- f. The number of years your organization has been in business under the present name.
- g. The number of years the business organization has been under the current management.
- h. A statement that the Respondent is in compliance with all applicable affirmative action (or similar) requirements with respect to its business activities, together with evidence of such compliance.
- i. Any judgments within the last three years in which Respondent has been adjudicated liable for professional malpractice. If yes, please explain.
- j. Whether the business organization is now or has been involved in any bankruptcy or re-organization proceedings in the last ten (10) years. If yes, please explain.
- k. Confirm appropriate federal and state licenses to perform activities.

3.3 Professional Information Requirement.

- a. Respondent shall submit a description of its overall experience in the provision of the type of services sought in the RFQ. At a minimum, the following information on past experience should be included as appropriate to the RFQ.
 - 1. Description and scope of work by Respondent.
 - 2. Name, address and contact information of references.
 - 3. Explanation of perceived relevance of the experience to the RFQ.
 - 4. Describe the services that Respondent would perform directly.
 - 5. Describe those portions of the Respondent's services, if any, for which the Respondent uses a sub-contractor. Identify all subcontractors the Respondent anticipates using in connection with this project.
 - 6. Does the Respondent normally employ union or non-union employees?
 - 7. Resumes of key employees.

8. A narrative statement of the Respondent's knowledge of the Borough's needs and goals.
9. List all immediate relatives of Principal(s) of Respondent who are Borough employees or elected officials of the Borough. For purposes of the above "immediate relative" means a spouse, parent, stepparent, brother, sister, child, stepchild, direct-line aunt or uncle, grandchild, and in-laws by reason of relation.
10. Proposed rate schedule for the provision of services.

SECTION 4

SUBMISSION OF QUALIFICATION STATEMENT

4.1 Submission to Designated Contact Person; Date.

Respondents must submit an original copy of their Qualification Statement. Also requested is one (1) electronic copy by either Thumb Drive or E-mail of their Qualification Statement to the Designated Contact Person.

SECTION 5

EVALUATION

5.1 Evaluation Objective.

The Joint Meeting's objective in soliciting Qualification Statements is to enable it to select a firm or organization that will provide high quality and cost-effective services to the citizens of North Arlington and Lyndhurst. The Joint Meeting will consider Qualification Statements only from firms or organizations that, in the Joint Meeting's judgment, have demonstrated the capability and willingness to provide high quality services to the citizens of the Borough of North Arlington and the Township of Lyndhurst in the manner described in this RFQ.

To be responsive, Qualification Statements must provide all requested information and must be in strict conformance with the instructions set forth herein. Qualification Statements and all related information must be bound, and signed and acknowledged by the Respondent.

5.2 Evaluation Criteria.

Proposals will be evaluated by the Joint Meeting on the basis of the most advantageous, all relevant factors considered. The evaluation will consider:

1. Experience and reputation in the field;
2. Knowledge of the Joint Meeting and the subject matter addressed under the contract;
3. Availability to accommodate the required meetings of the Joint Meeting;
and
4. Other factors demonstrated to be in the best interest of the Joint Meeting.
